#### Dear Councillor,

Section 131A and Schedule 14A of the Local Government Act 2001 [as inserted by Section 21(3) and 21(4)] of the Local Government Reform Act 2014 provided that it is a function of the Elected Council of a Local Authority to designate the reserved functions which may be performed by the Municipal District Members or by the Plenary Council. These reserved functions are set out in Schedule 14A – Part 2 of the Local Government Reform Act 2014.

Following discussion at a recent Corporate Policy Group meeting it was decided that a number of functions would in future be performed by the Municipal District Members. These are set out in Appendix 2.

Furthermore, the Corporate Policy Group agreed that the functions listed in Appendix 1 would no longer appear on the Monthly Agenda of the Plenary Council. These reserved functions will be listed for approval at the relevant Municipal District Meetings with effect from the new term of office i.e. June 2019.

I recommend to the Elected Members the passing of a resolution to give effect to the proposed designation of the reserved functions [to each Municipal District] listed in Appendix 2 under Section 131A of the Local Government Reform Act 2014.
